Good afternoon.

I have attached photos of the Metal Railing that we would use (I can drop off 10 copies if you would like). The railing is one that we have at one of our other houses that has held up very well over the past few years.

The design of the rail was done by our Structural Engineer and Welder so we did not have an Architect look at the rail. The height of the rail would be 43" which is the height of the rail that we currently use.

I do not have a photo of the metal plate/rod but the reasoning for the plate and rod is for added support on the porch where the old railing collapsed. The metal plate would be contoured with the column and painted the same color as the column. The metal rod would have a small nut that would secure it to the column.


