I can confirm that the window openings won't change size.

We are likely to re roof w Roy Askew but with a darker color, more matching our existing buildings.

He has a long track record in the community as even did the reddish shingled house across Rugby.

Still up in the air, but we'd like the choice of an architectural shingle as it would more match our existing roofs in quest of a connected look. And it would certainly fit w the vicinity.

As you know shingle is appreciable less expensive. This is a farmhouse structure approaching 150 years,

not particularly well built. We are tasked with finding the best and most practical use of our congregational

resources. We are keeping the ancient hidden or trough gutters to preserve the look but roofers hate 'em.

Standing seam 24 gauge bids ranged to 60k. Shingle w added sub ply would be close to 20 K.
