Mr. Signer read a proclamation in honor of Mr. James "Jim" Hingeley on the occasion of his retirement as public defender. Mr. Hingeley thanked Council for the proclamation.

Ms. Galvin announced the Parks and Recreation Advisory Board's public hearing about the Ragged Mountain trails on July 20 at the Jefferson School. She also announced the Citizen's Survey will go out in August and encouraged recipients to respond. She announced "It's About Choices" on July 21 at Burley Middle School. Ms. Szakos gave a summary of the National League of Cities committee meetings in Kansas City that she attended in June.

CITY MANAGER RESPONSE TO MATTERS BY THE PUBLIC

Mr. Jones addressed costs to swim at Washington Park Pool and crosswalk safety nearby brought up by Mr. Raymond Mason. He reviewed pool rates and the pass programs available to youth in the community. The City's traffic engineer is looking at possibilities for improved pedestrian safety in that area. Staff members have met with Ms. Herndon regarding her concerns about fair housing and parking near her home. In response to Mr. Fogel's remarks about disproportionate minority contact (DMC), the DMC task force has actively been involved in discussions regarding disproportionate contact, and there is positive progress in this area. He reviewed strategies for training and community outreach; more work is planned. Mr. Louis Oyola's request for a memorial bench for Sage Smith has been addressed, with staff identifying a location along West Main Street; staff is following up with Mr. Oyola and the family on this matter.

MATTERS BY THE PUBLIC

Ms. Naomi Roberts, St. Clair Ave., said she wants Council to help her save her street. She wants her street rezoned to 50 feet lots. People should not be allowed to build two-story houses 10 feet apart. She said she is disappointed by Council's lack of response.

Ms. Joann Robertson, Stand for the Silent, said two young ladies in the community have come together to do something positive in light of everything negative going on in the media.

They gave ribbons to everyone at the meeting, including the Councilors. Please take a picture of what you are doing in the community to spread peace and love. This week, they are picking up trash in neighborhoods and making cookies for law enforcement. Go to Facebook and search for Stand for the Silent to post your pictures.

Dr. Rick Turner, City resident and president of the local NAACP, said we all have an obligation to have a racially diverse police force. He said he was disappointed that there was only one Black inductee out of nine at last week's new officer ceremony. He said he believes young African American boys and girls want to be police officers, but they must be engaged early.

Mr. Ram Venkatanarayana, said he realized his memory was not working as well as it used to and discovered after multiple visits and a lot of money that he had Lyme's disease. He said he does not want to kill deer, but something needs to be done for the sake of public health.

Ms. Marta Keane, JABA, said there is a widening gap between seniors' needs and available funding as the elderly population increases regionally.

Ms. Laura Jones, 106 Holly Ct., said bow hunting deer within City limits is irresponsible and comes with many problems. She said Charlottesville could not be proud of such a decision. We should focus on other community problems, such as traffic issues.

Mr. Michael Roddy, 403 12th St. NE, said he originally planned to speak on parking downtown as the owner of Rapture. However, something more important came up; this past Friday night, an amplified band played music so loudly that it drove away outdoor diners and cost him revenue. The ordinance in place was not enforced.

Ms. Szakos confirmed with Mr. Jones that staff will follow up with citizens on timesensitive issues before the next Council meeting.

Mr. Signer announced that the first meeting in August is cancelled due to the scheduled summer break.

Ms. Galvin asked Mr. Jones to ensure staff is following up with Ms. Roberts.

Ms. Galvin thanked the PLACE Design Task Force for their work on getting the 3D model for the SIA created.

<u>PUBLIC HEARING / ORDINANCE</u>: POLLING PLACE CHANGE - BUFORD ELECTION PRECINCT (carried)

Polling Place Change - Buford Election Precinct

Ms. Anne Hemenway presented to Council. She reminded everyone that absentee voting starts in September, and the election is November 8. She answered clarifying questions from Council.

Ms. Szakos confirmed there will be signage at the Boys and Girls Club in case voters show up to direct them to the correct location. She made sure the new location complies with ADA requirements.

On motion, the public hearing was opened. Having no speakers, the public hearing was closed

On motion by Ms. Szakos, seconded by Ms. Galvin, the ordinance carried.

PUBLIC HEARING / ORDINANCE: WEST MAIN STREET DENSITY

West Main Street Density

Mr. Haluska presented to Council and reviewed the Planning Commission's recommendation.

Mr. Signer asked if staff received feedback from anyone. The Pregnancy Center of Virginia did call in opposition to this, and staff offered a response to their concerns.

Ms. Szakos asked if renovation projects would still have to provide parking. Mr. Haluska said by-right uses do not require additional parking, but there may be exceptions for extenuating circumstances.

Mr. Fenwick asked if parking or traffic studies have been conducted. Mr. Haluska said the increase in density is related to the number of required parking spaces; studies have not been conducted.

On motion, the public hearing was opened.

Ms. Jean Hiatt, 1534 Rugby Ave., asked Council to preserve the remaining historic buildings on Main Street.

Mr. Peter Kleeman, 407 Hedge St., said increased traffic in a low-capacity travel zone is a more pressing issue than parking.

Ms. Gennie Keller asked Council not to raise the by-right density for West Main Street to 200 dua. This would have negative outcomes for this area, and we are not ready for this decision. We should look at this more comprehensively in the future.

Ms. Valerie Long, 321 E. Main St., said on behalf of her clients, she is speaking in favor of increased by-right density. This will help address the affordable housing crisis, increase opportunities for entrepreneurial companies, and will help develop a critical mass on the West Main Street corridor in order to support business.

Ms. Sharon Marshall Davis, co-owner of 919, 915, and 917 West Main, currently inhabited by Habitat for Humanity, encouraged Council to follow the recommendations for the Planning Commission and seek more information before making a decision to increase density.

Having no further speakers, the public hearing was closed.

Ms. Galvin made a motion for an alternate ordinance, which changes the last two items referencing density. She proposed the following revisions: to Sec. 34-621, Density: Residential density shall not exceed sixty four (64) DUA; however, up to one hundred eighty (180) DUA may be allowed by special use permit. (West of the Drewary Brown Bridge), and to Sec. 34-641, Density: Residential density shall not exceed forty-three (43) DUA; however, up to one hundred twenty (120) DUA may be allowed by special use permit. (east of the Drewary Brown Bridge.)

Mr. Bellamy seconded the motion.

Councilors discussed the proposed motion.

Ms. Galvin entertained an amendment to send this back to the Planning Commission for review. Mr. Fenwick moved to defer this and send it back to the Planning Commission. Ms. Szakos amended the motion to include forwarding the work Ms. Galvin has done. Mr. Signer asked for consideration of supply and demand issues in Charlottesville with the housing stock.

Mr. Bellamy accepted the proposed amendments.

Mr. Signer said he is interested in evidence-based analysis on supply and demand.

Ms. Galvin said she still views this as an interim solution, and ultimately we should get rid of the SUP, predicated on having a robust supply of parking where we need it.

The motion to return this to the Planning Commission carried. (Ayes: Ms. Galvin, Ms. Szakos, Mr. Bellamy, Mr. Fenwick, Mr. Signer; Noes: None.)

Council took a recess at 9:01 p.m. and returned at 9:14 p.m.

<u>PUBLIC HEARING / ORDINANCE</u>: WATER STREET DISTRICT CORRIDOR REZONING (1st of 2 readings)

Water Street District Corridor Rezoning

Mr. Haluska presented to Council and answered clarifying questions.

Ms. Valerie Long, representing Midway Manor residents, thanked Council for their rezoning actions in March. She reviewed the proposals the zoning amendment would achieve.

On motion, the public hearing was opened.

Ms. Jean Hiatt, Preservation Piedmont, said they are pleased about proposed regulations for the Water Street district corridor. She urged Council to support the additional regulations for this corridor.

Ms. Gennie Keller, 504 North 1st St., said the Planning Commission is fully supportive of the zoning text amendments and appreciates the owners volunteering these.

Having no further speakers, the public hearing was closed.

Ms. Szakos moved to approve the zoning text amendment and thanked Midway Manor for being a good neighbor in this process, and by providing needed affordable housing. Ms. Galvin seconded the motion. The ordinance carried.

REPORT: URBAN DEER MANAGEMENT

<u>Urban Deer Management</u>

Mr. David Kocka with the Virginia Department of Game and Inland Fisheries presented to Council on urban deer management and answered clarifying questions for Council.

Ms. Szakos said we are already culling deer in inhumane ways, such as by hitting them with cars. The idea of urban hunting makes her very squeamish, but she realizes something must be done.

Mr. Signer asked for recommendations. Mr. Kocka recommended clarifying the ordinance in order to make it clear that discharging a bow is legal. The City could also join the urban archery group. Mr. Signer asked about deer meat programs. Mr. Kocka said decisions about what to do with the deer would be up to the individual land owners. Mr. Signer said this is free and decentralized, which makes this an attractive option.

Ms. Galvin said she is interested in a much more controlled culling option with a comparative cost estimate provided. Mr. Kocka estimated that it would cost \$400-\$500 per deer to hire sharp shooters for a controlled cull.

Council said they are interested in exploring targeted culling options including cost figures, as well as speaking to their peer localities. Mr. Signer asked for pros and cons to the decentralized approach to urban deer hunting. Mr. Fenwick said we need to make sure we solicit public comment. Mr. Jones will consult with staff and report back.

REPORT: CHARLOTTESVILLE AFFORDABLE HOUSING FUND UPDATE

Charlottesville Affordable Housing Fund Update

Ms. McHugh presented an update on the Charlottesville Affordable Housing Fund to Council and answered clarifying questions.

Ms. Galvin and Ms. Szakos thanked Ms. McHugh for all she has done for the City and for professionalizing the City's care of housing.

Ms. Galvin said form-based code is not a down-zoning and suggested having a conversation with the Housing Advisory Committee so there is improved understanding.

MATTERS BY THE PUBLIC

Ms. Rebecca Quinn, 104 4th St., said she is glad the discussion about managing deer population is back on the table. She asked if there are statistics about Lyme disease. Car insurance rates are set by jurisdiction, and a lot of factors go into those rates. She asked how much of our premium is related to deer impact and wondered if the City could lower rates by culling the population. She said bow hunters always wait until they have a good shot because they only have one.

Adjourned.
