PARKS AND RECREATION ADVISORY BOARD <u>MINUTES</u> October 18, 2017

The Parks and Recreation Advisory Board held a regular meeting on Wednesday,

October 18, 2017 at 5:30 p.m. @ Carver Recreation Center. Members present were: Ruth Barnett, Llezelle Dugger, Ned Michie, John Santoski and Jennifer Slack. Members absent: Elise Cruz, Anne Hemenway, Marlene Jones, David Hirschman

Guests: 4th year nursing students

Adoption of Minutes

• Ruth Barnett made a motion to adopt September 20, 2017 minutes, second by Jennifer Slack, motion was unanimously approved

Introduction of New Parks & Recreation Staff Member

 Vic Garber introduced Chris Carr as new Athletics Program Manager – worked @ Appalachian State University, has Master's degree in sports administration, 3rd day on the job. Has been involved in officiating, club sports and camps. Will be starting youth basketball program in a few weeks.

Meadowcreek Valley Master Plan Implementation

- Doug Ehman, City Council approved moving forward with Tap grants, received sign off from NDS for Kneedler Bridge, out to bid for spring work.
- Bid documents for section from Railroad Bridge to Brandywine to Purchasing by end of the month, bid primary and alternate trail. Bids could be back mid December.

Tonsler Park Master Plan Implementation Update

- Doug Ehman reported that the Tonsler Park Splash Pad construction was underway; work should be done by end of the year.
- Restroom building work should be done by end of November; will include locks on doors and timer

McIntire Park Projects Update

- Received a go on Skatepark project, purchase order released today, will be meeting before Thanksgiving with contractor & designers, work should start beginning of March. Will be renovating restrooms, pulling playground equipment by start of construction.
- Vic Garber reported that staff has to figure out what to do with present Skatepark equipment, new Skatepark facility should open approximately October, 2018
- Pedestrian bridge still waiting for approval from VDOT
- Ned Michie asked about trails, Doug Ehman replied that the package is in the process of being prepared

Citywide Parks & Recreation Master Plan Survey

- Doug Ehman reported that the Master Plan survey could be ready by middle of next week, sampling is done. Brian Daly stated that good comments came out of focus groups
- Ned Michie asked when the survey results come back? Doug Ehman replied that the collection window was about 90 days, sending out 2,000 questionnaires, looking for about 420 responses

Board Matters

- Llezelle Dugger asked for an update about the Tonsler Park Field House naming, Brian Daly replied that it will be on next month's agenda
- Naming of park for Emily Fornsdale Brian Daly stated that it was the collective opinion of the Advisory board that it did not rise to the guidelines of the naming policy, this information will be

transmitted to the family. Ruth Barnett stated that the land was not donated but purchased, Brian Daly stated that the land was purchased @ market value

• Jennifer Slack asked what staff saw new @ the NRPA conference, Brian Daly replied information on ball fields, play equipment, under water fitness activity, yoga mats – can secure to sides of pool, kettle ball, refurbishment of fiberglass slides, educational sessions, recreation programming

Directors Matters

- Vic Garber showed slides of the new Musical Playground @ Pen Park; grand opening was October 10, 2017, 5th grade class of Charlottesville Catholic School played a role on opening day program. VSA donated the cost of the playground.
- Playground is designed for children/adults with special needs music strategies stimulate speech development, provide cognitive & motor development and provide a meaningful environment for socialization.
- Brian Daly commented that it was a unique partnership, gave thanks to Parks & Therapeutic staffs, unique addition @ one of the busiest city parks.
- Reminder Halloween festival, Saturday, October 28 @ Pavilion on the Downtown Mall includes games, costume contest and trick or treating with merchants on the Downtown Mall

Guests: 4th year nursing students

- Nursing students stated that the group was attending meeting because they were asked to get more involved in community meetings
- Asked question about survey will it be available online? Doug Ehman replied that to preserve integrity it would be a paper document distributed across the city equally balanced, random stratified geographical, demographics drive what looking for.
- Asked what role nursing students could play? Vic Garber suggested involvement with wellness trends, stress management
- Brian Daly stated that staff was looking to create more formal partnerships with hospitals.

The Parks and Recreation Advisory Board held a regular meeting on Wednesday, November 15, 2017 at 5:30 p.m. @ Carver Recreation Center. Members present were: Elise Cruz, Anne Hemenway, David Hirschman and Marlene Jones, Members absent: Ruth Barnett, Llezelle Dugger, Ned Michie, John Santoski and Jennifer Slack Staff: Brian Daly, Doug Ehman, Vic Garber, Riaan Anthony Guest: Tierra Howard, NDS

<u>Adoption of Minutes</u>

Naming of Field House

• Postponed until December meeting

Hardy Drive Park Proposal

- Tierra Howard, Grants Coordinator Neighborhood Planning works with Housing & Community Development projects
- Priority neighborhood 10th & Page, group of residents formed a Task Force and have met to set priorities on how to spend CDBG funds including ADA improvements.
- Residents have stated that the land is not well maintained, feels it is an eyesore. Stated that Chris Gensic, Brian Daly & Doug Ehman have met with the group.
- Task Force has recommended that the area remain as a passive park, stated issues with drainage, underground utilities, box culvert and underground stream part of water management system. Potentially eligible as a historic area, will be under an environment review.
- Initial public engagement, neighborhood meeting included Westhaven was held @ Carver Center, learned site conditions, neighborhood survey-had good feedback, placed sign in actual space with link to survey, met with a lot of staff, received police and JABA feedback, plan to do more community engagement. Citizens want green space, think about safety issues, and want to incorporate adjacent railroad property, signage & art.
- \$550,000 funding available to put towards park, what is not used goes to next priority. CDBG funds have a deadline for use, need to spend a minimum of \$50,000 by April, and rest of funds by mid-April, 2019. Purchasing lighting might be first possibility to spend funds
- Looking into possible design competition
- Would like feedback from Advisory Board

Recreation Facility Operations

 Riaan Anthony, Facility Manager – Parks & Recreation gave an overview of facilities operations, recreation centers, community centers – Greenstone, Westhaven, South 1st Street, Friendship Court and Skatepark

Housing Sites

• Operate according to community, July 1 extended hours per City Council, 4-8 pm from 4-7 pm, provide meals program, substance for kids after school, free hot meal, contract with school,

licensed kitchen @ school, provided 9 months @ facilities, summer @ camp sites, separate funding sources

- Community centers snack for evening, staff went to workshops, looking @ possibility to attach snack to summer because only serve breakfast & lunch, snacks are served @ Housing sites
- Each center has 1 staff member, trying to request a 2nd staff member, limits # of kids, can be a safety issue, would like to accommodate all kids. Program goes up to 17 years; activities are for 8 & above.
- Housing centers meals first hour, enrichment activity arts & crafts, board games, physical activity. Field trip every quarter museum, pools, etc.

Recreation Centers

- <u>Key Center</u> recently completed upgrade of front lobby , gymnasium floor, next phase bathrooms, curb appeal
- 1 FT, 4-5 PT, 7 days, sewing, kiddie yoga, drop in programs, pickle ball, open basketball free to kids \$2 adults, summer, Teen Camp site are held @ center
- <u>Crow Center</u> adjacent to Walker school, open 3-8 pm, M-F, minor upgrades, painted facility inside, activities – boxing, Lego Robotics, dance, karate, lots of potential in next couple of years to expand, arts & crafts room, adjacent to Crow Pool, which Walker 5th graders use to learn to swim
- <u>Tonsler Center</u> Cherry Avenue, per City Council extended hours July 1, closed Sundays. Added stairs from tennis courts, basketball, trail, splash pad under construction, will start to look @
 Field House
- Open to community meetings for groups are held
- Long term goal changing philosophy for center, change culture of the park
- <u>Washington Park</u> after school M-F, 5-8 pm, enrichment, physical activity, averaging 3 kids a day, trying to look @ different ways to expand
- <u>Carver Center</u> busiest center, provides big program of rentals, 150 average, special events, multi-purpose room wedding, dinners, awards ceremonies. Activities include birthday parties, Family Prom, Masquerade Ball, Christmas craft, basketball,
- Access pass includes monthly fee, use @ Carver, Smith, and Key. Fitness room, Group X classes, access to gym.
- Anne Hemenway asked if there was a decline in attendance @ facilities since YMCA opened, Riaan Anthony responded that he has seen some decline but can't say if it's the YMCA. Brian Daly responded that the YMCA has not been open long enough for a real impact, but are having a hard time trying to find qualified instructors since being competitive market with YMCA
- <u>Skatepark</u> starting December 1st open weekends only, will be closed January & February, Hope construction will begin on new Skatepark in March
- <u>Facilities</u> budget \$460,000; attendees for all centers 175,000, housing sites 60,000, federal meals including summer 8,900 meals

Meadowcreek Valley Master Plan Implementation

- Doug Ehman stated they have received final plans from railroad, will go to Purchasing week after Thanksgiving
- Kneedler bridge final design has to be looked at, because of stream work, in process, local corp of engineers, in process
- Two TAP grants submitted for design & construction of trail
- Hydraulic Road underpass final design done, out for approvals, small area plan, looking @ land acquisition

Tonsler Park Master Plan Implementation Update

- Doug Ehman stated that the Field House is open for competitive bidding process first of the year for design
- Splash pad 25 percent complete, site work done, in ground utilities, restroom building Nov 21, 27th set for installation on schedule
- Restrooms could be operational in May

McIntire Park Projects Update

- Doug Ehman stated that contracts are in place for Pedestrian Bridge & Skatepark, starts first Monday in March, then meet together, projects will be working in the same area @ the same time. Figure out phasing, everything in place
- Pedestrian bridge first, Parks staff will be handling renovation of existing restrooms, installing septic tank
- Brian Daly stated that the RFP for Botanical garden itself has been received, have received responses from 23 architectural firms, moving along

Citywide Parks & Recreation Master Plan Survey

- Doug Ehman stated that the first round is out, have received some calls, 2% are bad addresses such as vacant properties. Will be following up letter in 10 days.
- Marlene Jones asked if there will be open data, Brian Daly replied yes

Matters by the Chair

- Elise Cruz asked about the property near Azalea, what was happening with naming? Brian Daly replied that the family has been informed of naming policy and that there might be a possibility of interpretive signage in future about family history of property
- Ragged Mountain Brian Daly reported that there was a court date in December regarding bike usage

Board Matters

- David Hirschman thanked staff @ Key Center for their work on Election Day
- Anne Hemenway stated that the staff @ Tonsler were also very helpful on Election Day
