Yes Estimated Date of Construction: 1950 ca Source of Date: Site Visit/Written Architectural Style: Description: This one-story, three-bay, stuccoed concrete block house is a typical mid-twentieth-century dwelling with a rectangular form, topped by a side-gable roof with asphalt shingles. It has an exterior end concrete block chimney (parged), with three projecting flues. A gabled portico supported by wrought metal posts and brackets shelters the front entry, and wrought iron railings lead up from the front walkway to the entry stairs. The front elevation features a steel casement window and a large fixed window with flanking casements; other windows in the house are double-hung sash with horizontal two-over-two lights. The basement foundation, partially above ground at the rear of the building, is of parged concrete blocks. A shed dormer takes up much of the rear roof plane, while a rear shed wing and a screened porch extend behind the main block of the house. Condition: Good Threats to Resource: None Known Additions/Alterations Description: Stucco was added some time after completion of the masonry work, but was intended from the onset of construction. A modern wooden wheelchair ramp of post and rail design provides access to the front door. Number of Stories: 1.0 Interior Plan Type: Accessed? No If not, why not? Denied Interior Description: Relationship of Secondary Resources to Property: A small frame wood or tool shed, clad in T-1-11 siding, is situated to the south of the house, near the rear stairs and along the eastern property line. Significance Statement:

The Hamiltons acquired this property in 1949. Melvina Hamilton, eldest daughter of Melvin and Gertrude Hamilton, was one of the first black students to attend Lane High School during the early period of school integration. "According to Mr. Hamilton, all the whites hated him because of his daughter's attendanceat Lane. Both he and his wife were approached numerous times by white citizens attempting to convince them that Melvina would suffer and her attendance would achieve little. A local banker who had loaned Mrs. Hamilton money was one of those who tried to use his influence to keep Melvina out of Lane. Mrs. Hamilton, an active member of the NAACP, politely yet flatly refused to yield. Mr. Hamilton countered the visitors' arguments with the wisdom that their girls would grow from the experience far more than they would be hurt." (Ridge Street Oral History, 89). Architecturally, the Hamilton House is a typical mid-twentieth-century dwelling with a good degree of integrity to its original construction.


