A RESOLUTION EXPRESSING SUPPORT FOR FEDERAL COMPREHENSIVE IMMIGRATION REFORM LEGISLATION OR ADMINISTRATIVE ACTION

WHEREAS, immigrants and their children comprise nearly ten percent of Virginia's population and more than half of them are naturalized citizens who are eligible to vote, new Americans (naturalized U.S. citizens and their U.S.-born children) representing 6.4% of the voting population; and,

WHEREAS, immigrants are a vibrant, productive, and vital part of Charlottesville's economy, diverse cultural fabric, and changing demographics; and

WHEREAS, the integration of immigrants and a comprehensive approach to solve our immigration system is critical to ensure that our city and state continue to have strong economies; and

WHEREAS, Comprehensive Immigration Reform will recommit our country to being both a nation of immigrants and a nation of laws.

NOW, THEREFORE, BE IT RESOLVED, that the Council of the City of Charlottesville hereby expresses its support for federal Comprehensive Immigration Reform legislation or administrative action which includes the following: improving the economic situation of all workers in the United States; finding a path to citizenship for undocumented immigrants working and living in the United States; reforming visa programs to keep families together, protecting workers' rights, and ensuring that future immigration is regulated and controlled; implementing smart, effective enforcement measures targeted at the worst violators of immigration and labor laws; integrating immigrants into our communities and country; and respecting the due process rights of all in the United States.

A RESOLUTION EXPRESSING THE INTENT OF THE CHARLOTTESVILLE CITY COUNCIL TO APPROPRIATE FUNDS TO SUPPORT SECTION 8 HOUSING VOUCHERS FOR A SINGLE ROOM OCCUPANCY FACILITY AT 401 FOURTH STREET, NW

WHEREAS, the Board of Commissioners of the Charlottesville Redevelopment and Housing Authority (CRHA) has agreed to allocate existing but unused Section 8 housing vouchers to provide rental assistance to low income individuals who are eligible to reside in a Single Room Occupancy (SRO) facility to be constructed and operated by The Crossings at Fourth and Preston, LLC at 401 Fourth Street, NW; and,

WHEREAS, CRHA does not currently have adequate funding to support the use of the Section 8 vouchers allocated for the SRO facility; and,

WHEREAS, the City of Charlottesville supports the construction and operation of the new SRO facility, and wishes to express its intent to contribute to the costs of new Section 8 housing vouchers that will provide rental assistance to low and very low income individuals and families.

NOW, THEREFORE, BE IT RESOLVED by the Council for the City of Charlottesville, Virginia that the Council hereby expresses its intent to appropriate funds in an amount that would support the issuance of up to twenty-one (21) Section 8 housing vouchers that can be used at the SRO facility to be developed by The Crossings at Fourth and Preston, LLC.

RESOLUTION AUTHORIZING PURCHASE OF PROPERTY (CITY TAX MAP 32, PARCEL 26) FROM REGION TEN COMMUNITY SERVICES BOARD, INC. (SRO FACILITY)

WHEREAS, the City desires to purchase, and Region Ten Community Services Board, Inc. ("Region Ten") has agreed to sell to the City of Charlottesville, parcels of land with the improvements thereon located at 401 4th Street, N.W., in the City of Charlottesville, more particularly identified as Parcel 26 on City Tax Map 32; and

WHEREAS, the subject property is shown on the attached 4-page plat dated January 4, 2010, by Lincoln Surveying; and

WHEREAS, the City Assessor has valued the subject property at \$1,840,500.00, and the City and Region Ten have signed a Purchase Agreement evidencing the terms of the sale of the subject property to the City for \$1,550,000.00, which funds have been appropriated in the FY2010 budget; and

WHEREAS, City staff have recommended the purchase of the subject property to allow construction and operation of a Single Room Occupancy (SRO) facility to provide affordable housing units for homeless and very low-income persons; now, therefore

BE IT RESOLVED by the Council for the City of Charlottesville, Virginia, that the City hereby authorizes the purchase of property at 401 4th Street, N.W. from Region Ten Community Services Board, Inc., as shown on the attached plat, the City Manager is hereby authorized to sign a Purchase Agreement, in form approved by the City Attorney, for the purchase of the subject property, and the City Attorney is hereby directed to take whatever steps are necessary to effect the closing of the conveyance of the subject property to the City.

AN ORDINANCE

AMENDING SECTION 19-139 OF ARTICLE V OF CHAPTER 19 OF THE CHARLOTTESVILLE CITY CODE, 1990, AS AMENDED, RELATED TO FAMILY HEALTH CARE COVERAGE FOR CITY RETIREES.

BE IT ORDAINED by the Council of the City of Charlottesville, Virginia, that Section 19-139 of Article V of Chapter 19 of the Code of the City of Charlottesville, 1990, as amended, is hereby amended and reordained, as follows:

CHAPTER 19. PERSONNEL

ARTICLE V. GROUP HEALTH INSURANCE PLAN

Notwithstanding the foregoing, enrollment of a retiree's family members is subject to certain restrictions that may vary from time to time, and the city reserves the right to amend its health care coverage plan from time to time as the city in its discretion deems appropriate.

AN ORDINANCE AMENDING AND REORDAINING SECTION 16-11 OF CHAPTER 16 (NOISE CONTROL) OF THE CHARLOTTESVILLE CITY CODE, 1990, AS AMENDED, RELATING TO NOISE FROM RESTAURANTS IN THE NEIGHBORHOOD COMMERCIAL CORRIDOR DISTRICT.

BE IT ORDAINED by the Council for the City of Charlottesville, Virginia, that Section 16-11 of Chapter 16 of the Code of the City of Charlottesville, as amended, is hereby amended and reordained, as follows:

Sec. 16-11. Sound levels; restaurants.

No person shall permit, operate or cause any source of <u>amplified</u> sound to create a sound level emanating from a restaurant during the hours between 11:00 p.m. and 6:00 a.m. in excess of seventy-five (75) dB(A) (65 dB(A) in the Neighborhood Commercial Corridor district, described at City Code Sec. 34-541) when measured at or outside the <u>a residential</u> property boundary.

AN ORDINANCE AUTHORIZING THE LEASING OF REAL PROPERTY WITHIN THE CITY OF CHARLOTTESVILLE, COMMONWEALTH OF VIRGINIA, LOCATED AT 401 FOURTH STREET, N.W., AND IDENTIFIED AS PARCEL 26 ON CITY TAX MAP 32.

WHEREAS, the City of Charlottesville is under contract to purchase property at 401 4th Street, N.W. in the City of Charlottesville, and seeks to lease said property for the purpose of allowing construction and operation of a Single Room Occupancy (SRO) facility; and

WHEREAS, the City Council for the City of Charlottesville finds that such lease is in the best interest of the City, as the construction and operation of the Single Room Occupancy facility by The Crossings at Fourth and Preston, LLC shall provide the Charlottesville community with affordable housing units for low income persons; and

WHEREAS, in accordance with <u>Virginia Code</u> Sections 15.2-2100, *et seq.*, this ordinance was duly advertised for the purpose of receiving bids; and

WHEREAS, in accordance with <u>Virginia Code</u> Section 15.2-2102, a bid has been selected; and

WHEREAS, in accordance with <u>Virginia Code</u> Section 15.2-1800(B), a public hearing was held on February 16, 2010 to give the public the opportunity to comment on the proposed lease of the above described land to a third party;

NOW, THEREFORE, BE IT ORDAINED by the Council for the City of Charlottesville, Virginia that the City Manager is hereby authorized to execute an Option to Lease with a proposed Ground Lease attached thereto, in substantially the same form as attached hereto, for the leasing of property at 401 4th Street, N.W., Charlottesville, Virginia to The Crossings at Fourth and Preston, LLC. Said Option to Lease and Ground Lease shall be approved as to form by the City Attorney prior to execution by the City Manager.

BE IT FURTHER ORDAINED that this Ordinance is conditioned upon the City acquiring title to the property at 401 4th Street, N.W. prior to execution of the Option to Lease and Ground Lease agreement by the City Manager.
