Subject: Re: Oakhart Social patio lighting

I'll talk to Allan Cadgene, he has been in the loop about this but has not seen the drawings. I'll ask him to reach out to you with his approval. The lights are to be attached to the building on the inside of the parapet (not visible except on the roof) with 1" stainless steel eye bolts anchored to a 2"x4" which in turn is to be anchored to the wall with epoxy and masonry anchors.

We have actually decided on 9 strings of lights so they will be even over the whole patio including over Public's space. This is a joint project between Public and Oakhart. Danial (owner of Public) had asked me to spearhead the effort.

I do not have a plan view, if it is absolutely necessary I can have one generated, I was just hoping to get this done without the cost of the CAD. If you need it just let me know.
