On behalf of the Psi Chapter of Sigma Chi House Corporation, I would like to formally request your approval for a 1-year extension of the Certificate of Appropriateness associated with the property located at 608 Preston Place. The Certificate of Appropriateness officially expires on September 18th.

On March 18, 2014, the BAR approved (5-0) the proposed renovations and addition as submitted at that meeting, with bollards added to protect hedges, and the option to use a metal roof over the additions. Since that time, the preliminary site plan for the project has been in the engineering design phase and under review by City of Charlottesville staff, but it has not yet been approved. More time is needed to complete the plan approvals and move forward into building permit review and approval.
