This one-story, three-bay, aluminum-sided concrete block house is a typical mid-twentieth-century dwelling with a rectangular form, topped by a side-gable roof with asphalt shingles. The basement foundation, partially above ground at the sides and rear of the building, is of parged concrete blocks. Two parged brick flues are present. The original windows were 6/6 double-hung wood sash, and the original front entry was a paneled wooden door with four glass upper panels. The one-story, three-bay shed-roofed front porch has had its supports replaced.

Condition: Good Threats to Resource: Major Alteration

Additions/Alterations Description:

During the 1997 survey of the property, the house was being remodeled with a series of exterior changes: novelty pattern aluminum siding was added to the walls (covering the stuccoed concrete blocks), the original windows were replaced with vinyl double-hung sash, and the original door was replaced with a modern metal door with a six-panel pattern.

The Tinsley Thomas House is a relatively late example (ca. 1950) of a typical early-to-mid-twentieth-century domestic form--the one-story, three-bay, four-room-plan house. A recent remodeling has reduced the historic integrity of the exterior by hiding the stuccoed concrete block walls and removal of original doors and windows.
