A single, unornamented brick flue is present at the rear roof plane. The original gabled front porch has had its supports replaced. The windows throughout the house are two-over-two double-hung sash. A gabled rear wing, built of similar materials and detailing as the rest of the house, extends across the building's full length. A gabled ell extends perpendicular to the wing at basement level. A screened porch is also present, attached to the north side of the rear wing. Condition: Good-Fair Threats to Resource: None Known Additions/Alterations Description: The original porch supports, probably wooden posts, have been replaced with wrought metal supports and balustrades. The front door is a modern replacement of the original.

The Morris House is a relatively late example of the one-story, three-bay, four-room house typically built along Lankford Avenue in the early-to-mid-twentieth century. The house is a twin to one next door (225 Lankford); presumably, both were built at the same time and as part of a small speculative development. The house is among a group of properties associated with historic black settlement of the area east of Ridge Street.
