Description of Proposed Work Charlottesville Mural Cooperative

I am writing to seek approval for a cooperative mural project involving students from a local high school (The Living Education Center), residents of Fifeville, regional citizens who believe in the restorative power of public art, and a world-renowned muralist from Philadelphia, Isaiah Zagar. These people have joined forces in an effort to revitalize community and promote walkability by creating vibrant, community-driven art throughout Charlottesville. It is our vision that this mural project would be the first of many of this style and serve as a model for future projects throughout the area.

The proposed site for the mural is located on 5th St. SW in the West Main Street Historic District. The wall retains the parking lot of the Station restaurant, and lies along the east side of the heavily-trafficked entrance corridor into the Fifeville neighborhood. The wall is 110'long and grows from 3.5' to 8' tall. The retaining wall has been donated for beautification by property owner, Gabe Silverman, who is enthusiastic about the proposed mural project. The site's location is ideal for Charlottesville first mural of this kind, since it is of a moderate size, within view of West Main Street, and will create a more defined and appealing entry into the neighborhoods beyond.

This spring, we will host a weekend workshop for 20 students, neighbors and general citizens led by muralist Isaiah Zager, where we will work together to design and create this mural. Mr.Zagar has been installing murals using his unique style since 1971, and is excited for the opportunity to teach his style in

Charlottesville. Mr.Zagar's murals are mosaics of tile, glass, and mortar. The resulting design is smooth (offering no safety concerns related to sharp protrusions) and structurally sound. The entire cooperative group will design the content of the mural, with input from nearby neighbors and business proprietors. Mr. Silverman has requested that we integrate a theme of "food, flowers, and markets," since the wall lies within close proximity of the Main Street Market. The style will be very similar to the examples given here and also on the website above.

We are confident that this mural will add to the artistic appeal of the 5th street area, thus contributing to general quality of life. We believe that this is a culturally sensitive community project that will be in harmony with its surroundings and contribute to tourism and economic growth in the area. Charlottesville Mural Project BAR meeting, 4/19/05

Per your request, I have compiled as much information about the style, materials, and color of the proposed mural as possible. Please note, the final design and colors will be determined on the weekend of the mural workshop with artist Isaiah Zagar's input. It is our first priority that the mural compliment its surroundings and we are sensitive to the culture and history of the local neighborhood.

Materials:


- -salvaged tile scraps of mostly neutral colors with blue, purple, and green highlights
 - -mirror pieces
 - -standard tile grout, to be painted with similar colors to highlight the tile designs
- -Buckingham slate to be used as a rain guard along the top of the project. This consideration was made to:
 - add a sense of traditional design and history, since this slate is known as "Thomas Jefferson's slate" and is the primary roofing material on University buildings,
 - ensure the longevity of the project, since blocking moisture from running behind the tile will extend the grout's life, and
 - emphasize safety by covering all raw cut tile edges.

Design theme:

We plan to design a mural that represents the community-building effect that <u>Food, Flowers, and Markets</u> can have in our neighborhoods. For example, the mural may show people gathering at a public space holding baskets of flowers and vegetables, or people riding their bikes to meet friends at a thriving market space.

The above referenced project was discussed before a meeting of the City of Charlottesville Board of Architectural Review (BAR) on April 19, 2005.

The BAR approved (6-1) the application as submitted for a community mural that will draw on donations from Virginia Tile and other sources, under the guidance of Isaiah Zagar and substantial community engagement for the mural to revitalize the street wall, finding that the proposal meets the Design Guidelines for Public Improvements, noting guideline #.2 under Public Sculpture, Statues, Art, Wall Murals and Foundations.

In accordance with Charlottesville City Code 34-285(b), this decision may be appealed to the City Council in writing within ten working days of the date of the decision. Written appeals should be directed to Jeanne Cox, Clerk of the City Council, PO Box 911, Charlottesville, VA 22902.









