# AN ORDINANCE

# AMENDING AND REORDAINING SECTIONS 34-86 AND 34-1200 OF CHAPTER 34 (ZONING) OF THE CODE OF THE CITY OF CHARLOTTESVILLE, 1990, AS AMENDED, RELATED TO ENFORCEMENT OF HISTORIC CONSERVATION DISTRICT REQUIREMENTS AND TO EXPAND THE DEFINITION OF CONTRIBUTING STRUCTURE.

**BE IT ORDAINED** by the Council for the City of Charlottesville, Virginia, that Section 34-86 of Article I (Administration), and Section 34-1200 of Article X (Definitions), both in Chapter 34 (Zoning) of the Charlottesville City Code, 1990, as amended, are hereby amended and reordained, as follows:

### **CHAPTER 34. ZONING**

# ARTICLE II. OVERLAY DISTRICTS

# **DIVISION 5. COMPLIANCE AND ENFORCEMENT**

Sec. 34-86. Schedule of civil penalties.

- (b) Any violation of the following provisions of this chapter shall be subject to a civil penalty of one hundred dollars (\$100.00) for the first violation, and a civil penalty of two hundred fifty dollars (\$250.00) for each subsequent violation arising from the same set of operative facts:

# ARTICLE X. DEFINITIONS

Sec. 34-1200. Definitions.

Contributing structure, as used within Article II, Division 2 (Historical Preservation and Architectural Design Control Overlay Districts) and Division 5 (Historic Conservation Overlay Districts), and when referring to a building or structure located within a major design control district identified within section 34-272 or within a conservation district identified within section 34-337 thereof, means a building or structure that, by location, design, setting, materials, workmanship, feeling or association adds to the district's sense of time and place and historical development.

# AN ORDINANCE AMENDING AND REORDAINING SECTION 34-337 OF CHAPTER 34 (ZONING) OF THE CODE OF THE CITY OF CHARLOTTESVILLE, 1990, AS AMENDED, REZONING CERTAIN PROPERTIES TO ADD A HISTORIC CONSERVATION OVERLAY DISTRICT DESIGNATION TO THEM.

**BE IT ORDAINED** by the Council of the City of Charlottesville, Virginia that Section 34-337 of Article II (Overlay Districts) of Chapter 34 (Zoning) of the Charlottesville City Code, 1990, as amended, is hereby amended and reordained, as follows:

### Sec. 34-337. Conservation districts.

The following areas have been determined by city council to meet the criteria for designation as a conservation district, the limits of which are shown on the city's zoning map:

(1) The (to be determined) Martha Jefferson Historic Conservation District: City Council has designated only certain buildings within this overlay district as "contributing structures." Those contributing structures are identified on a map included within the conservation district design guidelines, a copy of which is available within the department of neighborhood development services.
