I sent you the below e-mail last summer but never got a response. We are trying to wrap up the design and wanted to make sure we are doing things correctly. First, I was wrong below, we are going with EPDM which is white so the color won't change. The parapet still isn't changing, so the only visual difference is that there will no longer be small stone ballast on the roof, which again no one will notice from the surrounding right of ways. Also, Steven Johnson from my office is taking the lead on this project at this point. Please let him know if there are any requirements that he needs to comply with for you.

Mary,

The view from the street will not change. We will keep the parapet the same, including the ceramic cap on the sides. The roof material will change. Right now it is ballasted but the new roof will fully adhered without ballast. But again, no one will notice this difference from the street. We have the choice of going with white or black material

color. The current is black, but Stacy Hall, which is attached to this building, is white. Our preference is white because it reduces solar heat load. Since people on the street won't see the color change and because it will be identical in color to the attached building's roof, I would not see why anyone would complain about switching from black to white.
