The committee discussed the local historic markers. They added to the previous list for the year 2001, the George Rogers Clark statue. For the year 2005 the First Presbyterian Church and the Holy Comforter Catholic Church. They indicated that the church category in 2005 is focusing on original churches in the community and the important role they have played in the early history in the community. Ms. Ingrid Smyer-Kelly stated that the architectures of the churches should also be considered.

The committee discussed two alternate sizes for the local historic markers. It was agreed that the words on these markers would be limited, between 150-250 words. We need not mention every minister of the church. The wording of the 2001 local markers will be decided upon at the next meeting.

Mr. Beliles stated that, 2002 is the 250th anniversary of birth of George Rogers Clark. Sons of the American Revolution have approached him about the celebration of this anniversary. Mr. Beliles suggested a local marker near the statue of George Rogers Clark to be placed near the University, which could be placed on a stone on the ground. Private funding will have to be raised for this marker. We should also ask the University of Virginia and the Garden Club to beautify the area around the statue.

Ms. Helena Devereux felt there should not be too many local markers per year. Otherwise, they will become less meaningful and valuable.

Mr. Huja informed the committee that the State of Virginia, State Historic Board, has approved the state markers for the "Georgia O'Keefe House "and the "Farm". We need to discuss the state markers for next year.

Mr. Garrett Smith commented that he is waiting for confirmation of money from the Perry Foundation before he pays any more funds to the graphic artist. Three-tour maps still need to be approved upon. He hopes to have the text finalized by the end of January. Mr. Fife stated that he would look into the funding issue. It was agreed that the booklet should acknowledge the volunteers, the funders, the task force, and the staff. Mr. Smith also asked for volunteers for walking tours in the field. Ms. Caperton and Ms. Smyer-Kelly volunteered.

Mr. Huja indicated that he is working with Rick Britton on a downtown map of art, cultural and history. With no further business the meeting adjourned at 4:45
