#### MONTICELLO WINE COMPANY (draft 10/01/04)

The Monticello Wine Company's four-story brick building and cellar stood midway on the north side of Perry Drive. Founded in 1873 using grapes from local vineyards, the winery showcased the growth of the commercial wine industry in Virginia after the Civil War. Charlottesville boosters often referred to the area as the "Wine Capital of Virginia." The winery received highest awards from exhibitions in this country and abroad. In 1904 it's Champagne christened the USS Virginia. The winery operated until Prohibition began in Virginia in 1916 and it's building was destroyed by fire in 1937. The home of the winery's general manager Adolph Russow stands nearby at 212 Wine Street.

### **Marker Text**

# The Monticello Wine Company

Midway on the North side of Perry drive stood the four-story brick building of the Monticello Wine Company and cellar. Founded in 1873 and operated until Prohibition, it signaled the birth of Virginia's commercial wine industry using grapes from local vineyards. Highest awards were received from exhibitions in this country and abroad, as Charlottesville became the "Wine Capital of Virginia." In 1904 the company's Champagne christened the USS Virginia. By 1906 annual wine production exceeded 50,000 gallons. Used many years for storage, the building was destroyed by fire in 1937. The c. 1880 home of prominent winemaker Adolph Russow still stands nearby at 212 Wine Street.
