Site Description:

January 2020: This one-story church is located on the west corner of Grady Avenue and 12th Street NW. The building is surrounded on the street sides by a chain link fence. At the southeast end of the southwest property line, there is a short concrete block wall. The rest of the southwest property line consists of a brand-new wood fence. There is a metal smoker and a brick fire pit to the rear. The land to the northwest of the fire pit is part of a separately owned parcel. This property consists of a church.

January 2020: According to the Charlottesville City Property Records, this house was constructed in 1920 and converted into a church around 1950 (City of Charlottesville GIS Viewer 2020). Historically, it has also had an address of 421 and 519 12th Street NW. The building is depicted on the 1920 Sanborn Maps as a one-story dwelling with a rear, partial-width, one-story wing and a one-story outbuilding. By 1929, the rear wing was expanded to full width and the outbuilding was removed. By 1950, the building was identified on Sanborn Maps as a "Church (Colored)" and had a rear one-story hyphen connected to a one-story addition. Between 1950 and 1968, the church achieved its present-day footprint with the removal of the hyphen and addition, and construction of the current partial-width the Charlette as present-day rootprint with the removal of the hyphen and addition, and construction of the current partial-width rear addition (Sanborn Map Company 1920; Sanborn Map Company 1950; NETR 1968). The 1950 city directory identifies the property as Christ's Temple; there is no listing for this address in the 1959 city directory (Hill Directory Co. 1950; Hill Directory Co. 1959). The property has been owned by Arthur W. and Emma F. Brown since 1979 (City of Charlottesville GIS Viewer 2020).

This building is currently occupied by Faith, Hope and Love Church. This church was founded by Charlottesville native Sarah A. Kelley, who started a church in her own home in 1985. Her congregation moved to this location in 1990. In 1996, she opened the Faith, Hope and Love International Healing & Deliverance Center in Hickory Hill, Virginia (Another Chance Ministry 2019). Kelley was the first African American female nurse at Martha Jefferson Hospital, first African American female computer programmer for the highway department, and the first African American chaplain in the chaplaincy program at the University of Virginia (Dunlap Sathe 2018).

This property retains good integrity of location. The integrity of setting has been slightly compromised by the construction of the neighboring house to the southwest in 1979, which replaced an earlier house (City of Charlottesville GIS Viewer 2020). The integrity of design, materials, and workmanship has been slightly compromised by a replacement front door. The integrity of feeling and association has not been compromised by its conversion from a residence to a church, as the change happened over 50 years ago and because its front-gabled form is similar to building forms found in the neighborhood. Overall, this property retains good integrity.

This property is recommended not individually eligible for listing in the NRHP due to a lack of historical significance. Although Sarah A. Kelley may have local historical significance under Criterion B, this property is not likely to best reflect her historical significance as her significant achievements pre-date her establishment of this congregation. Additionally, it is located in the potential 10th & Page Historic District, which is recommended as potentially eligible for listing in the NRHP. Further study is recommended to determine if the 10th & Page Historic District is eligible for listing in the NRHP under Criterion A in the areas of Ethnic Heritage, Community Planning and Development, and Social History, and under Criterion C in the area of Architecture. This property includes one contributing primary resource.

January 2020: This one-story church is clad in stucco and has a front gable roof that is covered with asphalt shingles. The primary entranceway is in the center of the southeast-facing facade and accessed by a concrete step. There is an interior brown stretcher-bond brick chimney on the southwest roof slope. There is a one-story, partial-width addition on the northwest elevation. The addition has a shed roof and a secondary entrance on the northeast elevation. Visible fenestration consists of single-leaf wood doors; and two-over-two, double-hung, wood windows.
