January 2020: According to the Charlottesville City Property Records, this house was constructed in 1951 (City of Charlottesville GIS Viewer 2020). This property does not appear on the 1950 Sanborn Maps, but is visible in a 1963 aerial photograph (Sanborn Map Company 1950; NETR 1963). The shed was built between 1994 and 2002 (NETR 1994; NETR 2002). As of 1959, this address was occupied by Trusgo's Record Corner and Trusgo's Everyday Market (Hill Directory Co. 1959). The building was converted into a residence at an unknown date. It was owned by Wilbert Trusgo Farrar, Jr. between 1991 and 2006 (City of Charlottesville GIS Viewer 2020). Given his name, he likely owned this property prior to 1991. He also was associated with 836 Page Street across the street in 1959 (Hill Directory Co. 1959).		
This property retains good integrity of location. The integrity of setting is slightly compromised by the construction of the neighboring house to the east in 1980 (City of Charlottesville GIS Viewer 2020). The integrity of feeling and association has been slightly compromised by its conversion from a commercial property to a residential property. The integrity of design, materials, and workmanship is compromised by replacement windows with slightly altered openings, and likely other exterior changes to convert it into a residence. Overall, this property retains fair integrity.		
This property is recommended as not individually eligible for listing in the NRHP due to a lack of historical significance. However, it is located in the potential 10th & Page Historic District, which is recommended as potentially eligible for listing in the NRHP. Further study is recommended to determine if the 10th & Page Historic District is eligible for listing in the NRHP under Criterion A in the areas of Ethnic Heritage, Community Planning and Development, and Social History, and under Criterion C in the area of Architecture. This property includes one contributing primary resource and one non-contributing secondary resource.

January 2020: This one-story house sits on a concrete foundation, is clad in vertical wood siding, and has a side-gabled roof that is covered in asphalt shingles. There is an interior stuccoed chimney along the northwest roofline. The northwest-facing facade features two partial-width shed roof porches that are supported by square stuccoed columns. The southernmost porch has a patterned concrete block knee wall, and provides access to the main entrance. The northernmost porch has wood latticework between the columns, and provides access to a secondary entrance. Both entrances are accessed via a concrete step. There are two skylight on the northwest roof slope. On the southwest elevation, facing the street, there are patterned open concrete blocks above the windows. All visible windows have fixed wood shutters. Visible fenestration includes one-over-one, double-hung, vinyl windows; sliding vinyl windows; and single-leaf wood doors, one of which has a metal and glass storm door.
