Sorry for the confusion on this issue. I reviewed the available colors in the new line of shingles at the project site, and see two possible colors that could be equivalent replacements for the approved "Mystic Slate" color in the BAR package. I did not want to give the contractor the approval to order the material until we could verify that this was acceptable to the BAR and any other interested groups. Please see the attached pictures as well, which show the sample boards that are in the project trailer.

- 001 shows all three shingle sample boards sitting on the plan desk in the trailer
- 002 is the selected shingle in the BAR submission "Mystic Slate" which has been discontinued
- 003 is one possible alternate "English Gray Slate" (our preferred selection)
- 004 is the other possible alternate "Antique Slate"
- 096 is a picture of the existing roof and the mountains beyond. As you can see, the existing roof is a very gray shingle.
