Mr. Herbert called the meeting to order at 4:06 p.m.

1. CERTIFICATE OF APPROPRIATENESS

1. BAR 91-01-353

815 W. Main Street Exterior Lights & Improve Fire Escape at Rear Hi Starr Ltd., Applicant

Mr. Boger said Hi-Starr Limited Partnership has submitted an application to improve the back fire escape through widening and installing a roof over it for weather protection. The applicant also proposes to install nine small black lights (B1-A) under the second story windows on the front of the building. These improvements are necessary because the Cotten Exchange is expanding into the second floor of the adjacent building.

We have reviewed the application and have no major problem with it. However we would request that the wood railings, stairs, etc. be stained, because natural wood is not appropriate for use in an urban setting.

Representatives of Hi Starr Ltd. were present and discussed at length with the Board the proposed exterior work. Following the discussion, Mr. Wassenaar moved to approve the Certificate of Appropriateness with the following conditions:

Nine Lights on Front

- (a) The conduit for the lights must be mounted on the cap flashing above the awning, and the conduit and electrical boxes painted the same color as the walls.
- (b) The lights must be centered under each window
- (c) The lights are to project 6" to 8" from the wall, and the stems are to be painted black.

(d) After installation, the spots are to be adjusted so that the illumination is uniform in appearance.

Fire Escape

- (a) All natural wood on the stairs and walkway from Main Street, post, etc. is to be stained.
- (b) The color to be used is to be administratively approved by the Department of Community Development

The motion was seconded by Mr. Bullard and unanimously passed by all members present.

2. BAR 91-01-354

512 W. Main Street Proposed Addition Paul Grady, Applicant

Mr. Paul Grady was present and he briefly presented his plans for an addition to the east of the Blue Moon Diner at 512 W. Main Street. Following a brief discussion, the Board had the following comments on the proposed work:

- (a) Consideration should be given to removing the front door and replacing it with a square window.
- (b) Mr. Grady needed to address handicapped access to the building and within the building because this may have a significant influence on the design of the addition.

Once the above issues have been addressed, the final drawing can be prepared for review and approval by the Board.

2. OTHER BUSINESS

There was a brief discussion on a proposal by the City to erect a wire fence along one side of the cemetery on Lexington Avenue. The Board asked staff to research the history of the cemetery to see if it is subject to the architectural design controls.
