John Farmer called the meeting to order at 7:51 p.m. and called for consideration of the minutes.

A. Minutes

Mrs. Schatz offered the following corrections:

Page 2: paragraph 2 - "motioned" should be "moved".
Other Items, #1 c. - "appraised" should be "appraisal".
E. 1., second sentence should read - "He wanted to paint it grey with white trim and requested those colors be accepted in principle."
E. 1., third sentence - "color" should be "colors", and "of" should be "if".

Mrs. Schatz moved approval of the February 25, 1981 regular meeting minutes as corrected. Mr. Herndon seconded. The motion passed unanimously.

B. Old Applications

1. BAR 80-116

Watson House (CAARC) 515 Park Street Amendment to Fire Stair (roof) Region Ten Community Services

Mr. Tom Hubbard gave a brief presentation of the changes and the reasons for them as outlined in the letter, dated February 17, 1981, to the Board. The changes required by the State Fire Marshall include: a roof over the stair, risers, and wire mesh glass in the window on the first landing.

There was much discussion on these and other items. Mr. Hubbard, referring to a letter received this day from the Fire Marshall, said solid risers may not be required and, if not, they would prefer to leave them out. He added, however, that all exposed wood will be stained the dark "coffee" brown approved earlier by the Board.

Mr. Farmer asked about the galvanized metal flashing and its color. He added that it probably should be painted to match the "coffee" stain.

Mrs. Schatz moved that the amendments be accepted as presented with all exposed wood stained "coffee" brown, the galvanized flashing painted "coffee" brown and the roof to be dark grey. Mr. Herndon seconded the motion. The motion passed unanimously.

2. BAR 81-124

Fowler House 204 Ridge Street Painting exterior Wilson W. Cropp, II

After viewing the proposed color sample (Glidden "fieldstone" grey for the siding), and after some discussion, Mr. Herndon moved approval of the color as submitted with snow white trim. Mrs. Smith seconded the motion. The motion passed unanimously.

The condition of the front door was brought up by the applicant. He asked for suggestions.

Mrs. Schatz moved approval of the front door as either natural wood or white paint. Mrs. Smith seconded the motion. The motion passed unanimously.

C. Other Items

There were none.

D. Other Matters Brought by the Public Not on the Agenda

Mr. George Allen, Jr., the owner of 109 East Jefferson Street ("Social Hall"), offered a request to replace the standing seam tin roof with a Johns Mansfield 20-year fiberglass shingle roof. He asked for advice concerning the color to use, suggesting dark grey as a possibility.

There was considerable discussion on the condition of the existing roof, alternatives to shingles, comparative costs, and the significance of this particular structure to the ADC.

It was agreed unanimously that the roof, if it needs to be replaced, should be replaced with a standing seam metal roof only.

Mr. Allen agreed and withdrew his application.

E. Chairman's Report

Mr. Farmer brought up the recent "controversy" over whether or not the Levy Opera House ever had a pediment roof. There was considerable discussion on this topic.

F. Board Members' Reports

There were none.

G. Department of Community Development Report

There was none.
