## H. JOINT PUBLIC HEARINGS

ZT-07-09-22: (Conditional Zoning Ordinance) An ordinance to amend and re-ordain §§ 34-61, 34-62, 34-64 and 34-1200 of the Code of The City of Charlottesville, 1990, as amended (Zoning Ordinance), to allow the City Council to adopt reasonable conditions proffered in conjunction with rezoning applications, in accordance with Virginia State Code §15.2-2303. The 2007 amendments to the Virginia Code give localities such as the City of Charlottesville the option to adopt the conditional zoning authority granted under Virginia Code §15.2-2303 rather than Virginia Code §15.2-2298. An ordinance utilizing the provisions of Virginia Code §15.2-2203 would grant the

City greater latitude concerning the types of conditions, or proffers, that may be accepted from property owners in conjunction with rezoning applications. *-Recommended approval to City Council*
