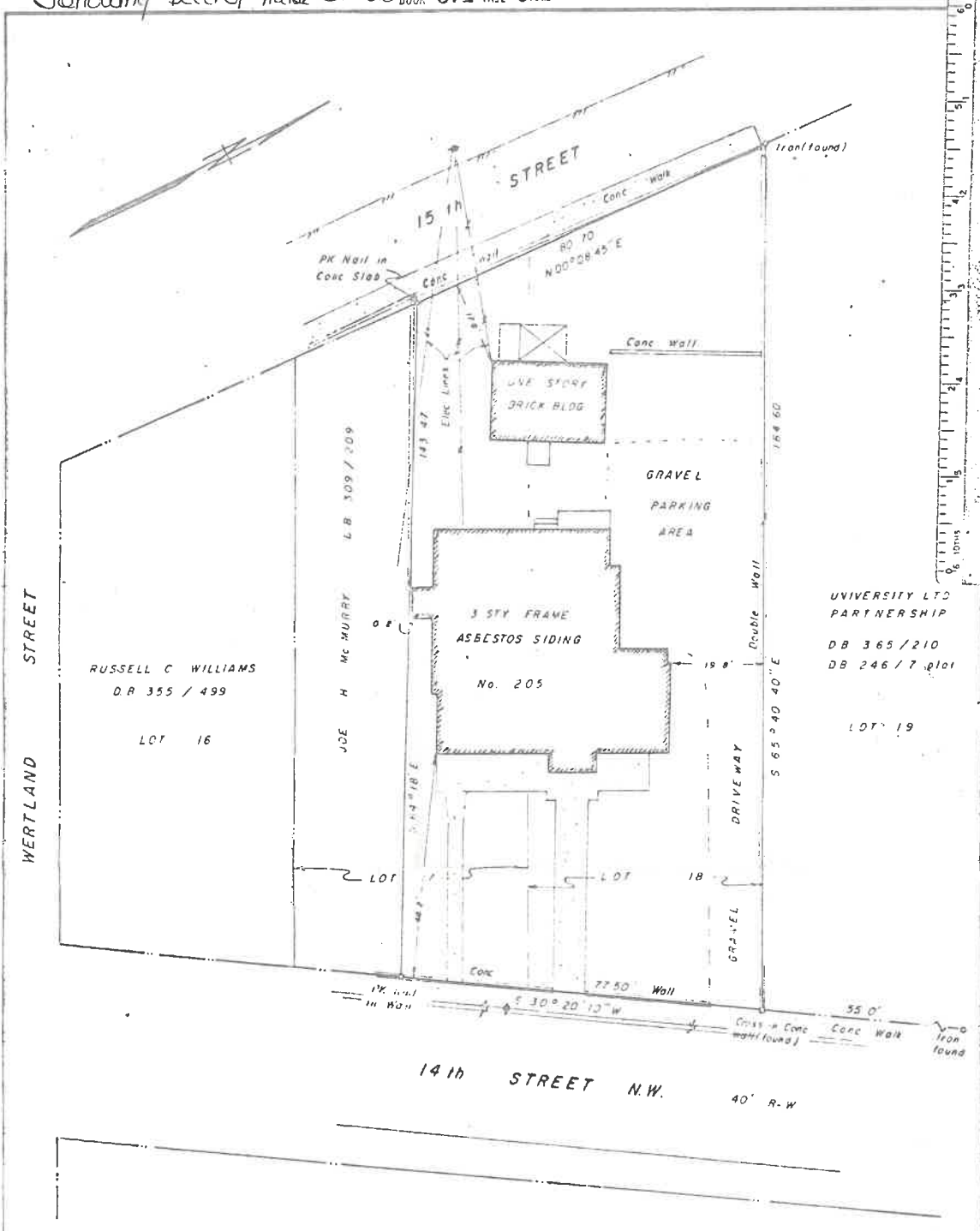

CHARLOTTESVILLE, VIRGINIA

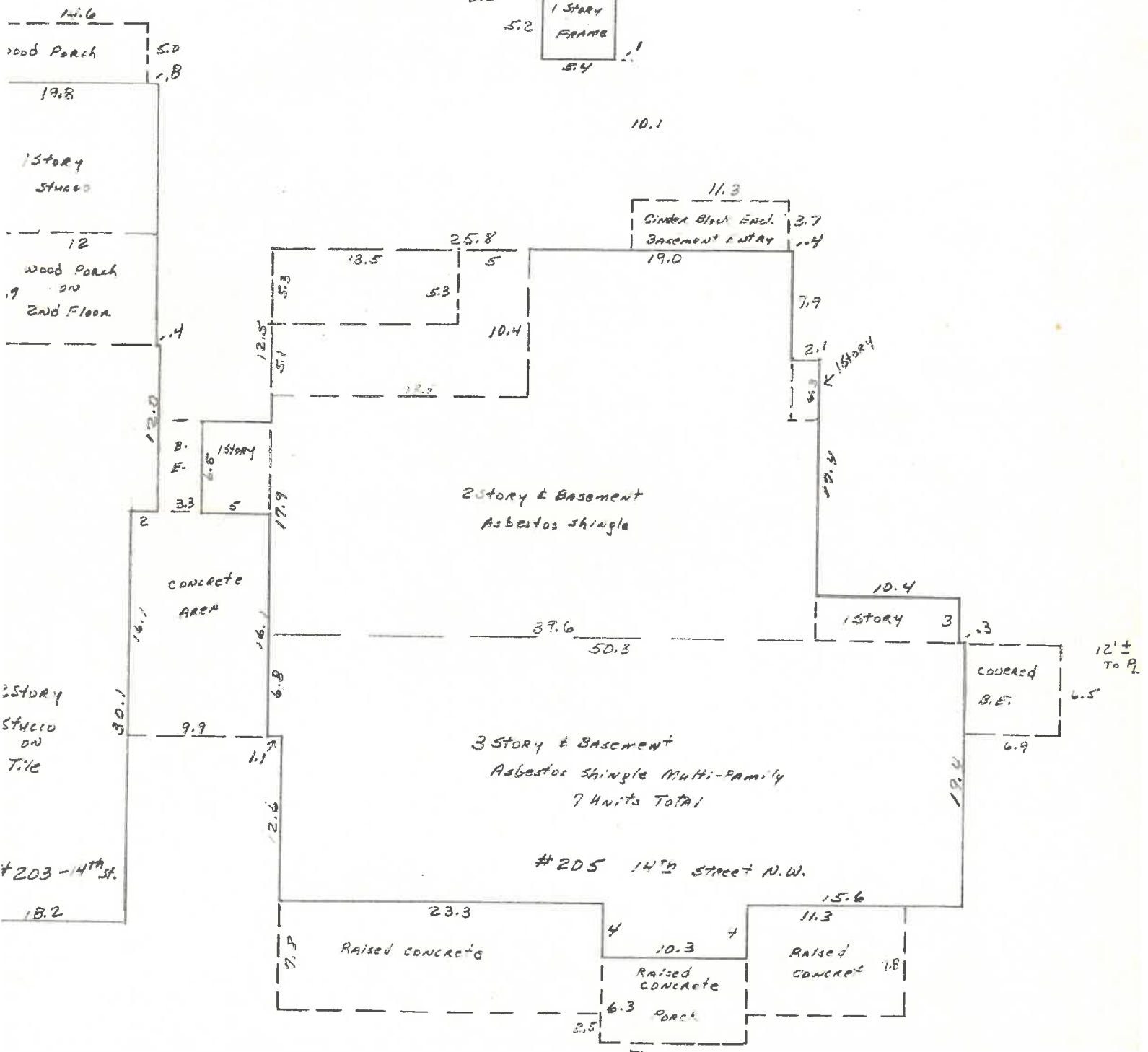
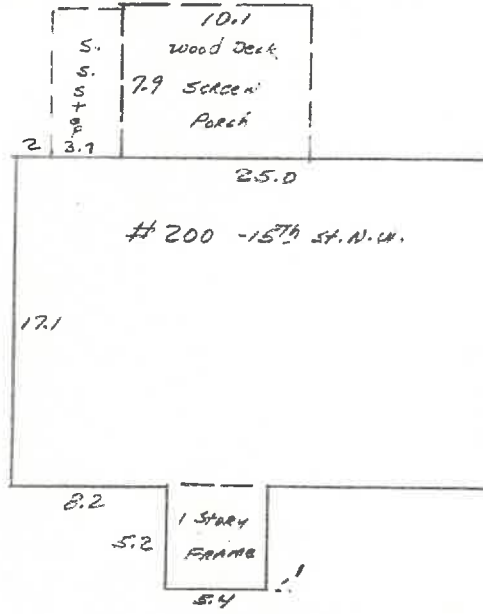

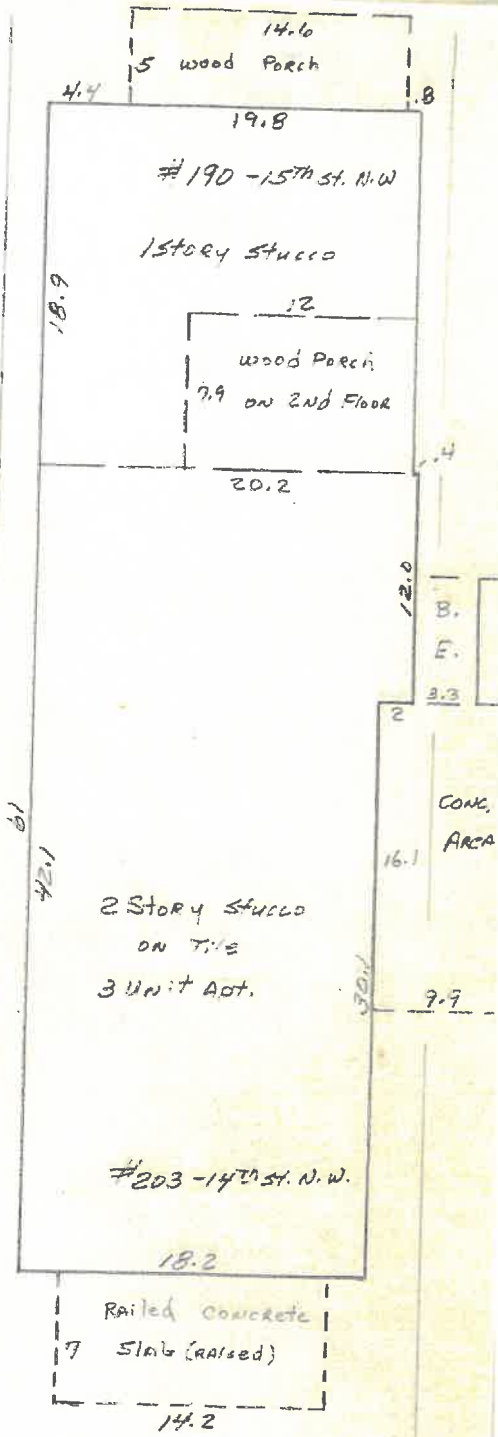
