I-1 Presentation- Master Plan Update- Mike Svetz PROS Consulting

- Trail Connectivity Analysis focusing on recreational paved trails
- Analysis aims to identify missing segments, expand the shared use system, and prioritize projects
- Existing trails, funded projects, and potential future connections were discussed
- Prioritization criteria include utilization, geographic distribution, land acquisition, and purpose of the trail
- Framework Plans for Five Specific Parks

- Plans for each park outline potential improvements and considerations for future development
- Plans are high-level ideas and test fits intended to be flexible and provide opportunities for community input

Tonsler Park Framework Plan

- Improvements to basketball courts
- Addition of picnic shelters
- Refurbishing of concession building
- Repurposing of sports fields
- Consider the needs of the immigrant and refugee population in the area

Washington Park Framework Plan

- Addresses the park's two distinct areas (upper and lower)
- Proposes adding picnic shelters in lower area
- Adding restrooms
- Creating a nature play area
- Repurposing the baseball field for other uses such as a dog park and/or community garden

Market Street Park Framework Plan

- o Creating a flexible event space
- Improving accessibility
- Balancing the needs of the general public with concerns about the homeless population
- Widening entryways into the park
- Adding new seating areas

Court Square Framework Plan

- Enhanced seating
- Improved plantings
- Adding a fountain

Kindlewood Park Framework Plan

- This is a new redeveloped park in the Friendship Court community
- Plan includes various amenities such as basketball court, picnic shelter, and community gardens
- December 16th- Present to City Council

- December 17th- Finalize recommendations and strategies workshop with staff
- December 17th- Public meeting/open house at Carver Rec at 6pm
- January/February the Master Plan will go through
