The Parks and Recreation Advisory Board held a regular meeting on Wednesday, November 28, 2012 at 5:00 p.m. held @ Parks & Recreation conference room. Members present were: Ruth Barnett, Byron Brown, David Hirschman, John Kammauff, Sean McCord, Jennifer McKeever, Ned Michie, Jordan Phemister and Natasha Sienitsky.

Minutes:

Ruth Barnett made a motion to approve October 17, 2012 minutes, second by Byron Brown, motion was unanimously approved.

New Board Member

Jennifer McKeever welcomed Natasha Sienitsky to the Advisory Board, members introduced themselves.

March Meeting

➤ Brian Daly stated that there was a budget forum scheduled for the same time as the March advisory board meeting and they would like to use City Space. Jennifer McKeever agreed to give the space for the budget forum and said they would be flexible with the March meeting.

Azalea Park

- ➤ Brian Daly referred to the Azalea Park Master Plan and stated that the Dog Park was in place and that the new play equipment had been selected. Remainder of work will be done in spring and in the new FY14.
- Next couple of weeks trail, access control will be developed
- New amenity Dog water fountain dedication this Friday @ 12 noon,

- Master plan walking through engineering drawings, site plan review going through NDS
- ➤ A lot of work will be managed in house —will save significant funds
- ➤ Will engage w/community to talk about play equipment

Carver Recreation Center

- ➤ Brian Daly reported that staff was preparing to reopen Carver Recreation Center and that punch list work was going on.
- > Temporary certificate of occupancy should be received within next two weeks
- ➤ Weight/fitness equipment has arrived this week
- ➤ Ribbon cutting middle of December
- \triangleright Grand opening 1/19/13 -= entire facility will be open complimentary admission, classes,
- New business banquet space lower multi- purpose room, birthdays, meetings, etc.
- Access pass will be good at either facility
- > Open gym time, pass also good @ Key Center
- > Classes in brochure not included in pass, but there will be in drop in classes that are included.
- Suggested December meeting held @ Carver Center for tour of the facility

Meadowcreek

- ➤ Brian Daly reported that the 3rd meeting held @ Greenbrier School last night charette meeting, showed board members maps from the meeting.
- Focus on trails, connections, crossings, some groups interested in disc golf
- Garden section want garden plots to stay,
- Public hearing has not been set yet
- ➤ 1/17/13 taking comments for this meeting
- > All documents & comments will be posted on website

Tonsler Park

- ➤ Next meeting 12/13 @ Tonsler Park charette
- Community comments want park improved, water feature added.
- Low attendance @ meetings so far
- ➤ Map distributed to schools and centers for youth responses
- Natasha Sienitsky stated that she went to the first public hearing liked hearing history and past master plans, Heard people were disappointed couldn't mark comments on maps. Suggested open house w/certain hours;
- ➤ Heard from neighbors multi use field, most activity around basketball court, asked about lights, Brian Daly agreed that they are poorly lighted
- Asked about plans for the funds of land acquisition great opportunity to connect with privately owned land in back of park
- ➤ Planning Commission —Cherry Avenue corridor for deeper study, would like to see how it all fits together not just park
- ➤ Brian Daly stated that they have had conversations with Mr. Woodard about plans, they did show some connection, plans that were 12 years old
- > John Kammauff suggested a 50/70 league development possibly move fence back to fit
- David Hirschman asked if there were new plans for the old IGA area.

CIP

- Brian Daly reviewed and distributed the CIP matrix, list of unfunded projects, stated that what was on page 2 matrix shows what was put forward
- > First draft of CIP not final document
- Page 2 P&R section Washington Park expansion funding was pushed out full year to FY 17
- Rives current FY only
- ➤ McIntire master plan proposes pushing back another year
- Skatepark presently has funding from interchange project used to create pad for movable equipment moved
- Commitment to Skatepark temporary location, move portable equipment, work with committee on design of Skatepark
- ➤ Wading pool will operate next year for final year
- Unfunded list includes not just P&R

- ➤ Jennifer McKeever asked about the swim pass including swim test marked, Vic Garber replied that there is not a final answer at this time, Brian Daly stated that the intention is to make it happen.
